From I-39 S, merge onto US-10 W (roughly 10 miles)

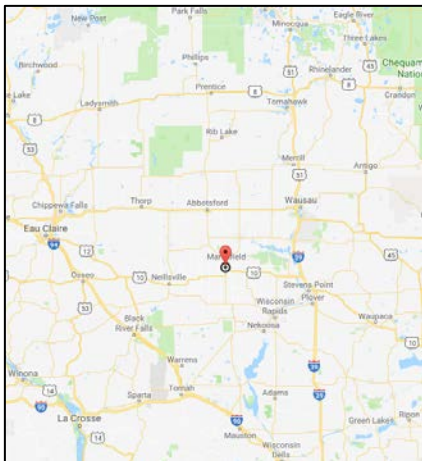
