What is the overall deductible ?	<p>\$2,800 individual / \$5,600 family for Tier 1 Network</p> <p>\$3,500 individual / \$7,000 family for Tier 2 Network</p> <p>\$5,000 individual / \$10,000 family for Tier 3 Out-of-Network</p>	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care at Tier 1 is covered before you meet your deductible	This plan covers some items and services even if you haven't yet met the deductible amount, but a copay or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . Are there other deductibles for specific services?	No.	You don't have to meet deductibles for specific services.
What is the out-of-pocket limit for this plan ?	<p>\$4,000 individual / \$8,000 family for Tier 1 Network</p> <p>\$7,000 individual / \$14,000 family for Tier 2 Network</p> <p>\$9,000 individual / \$18,000 family for Tier 3 Out-of-Network</p>	The out-of-pocket limit is the most you could pay in a year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met.
What is not included in the out-of-pocket limit ?	Premiums , balance-billing charges, amounts over usual, reasonable & customary (UCR) , and health care this plan does not cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
Will you pay less if you use a network provider ?	Yes. See www.securityhealth.org or call 1-800-570-8760 for a list of network providers .	This plan uses a provider network . You will pay less if you use a provider in the plan's network . You will pay the most if you use an out-of-network provider , and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Does this plan provide Minimum Essential Coverage? Yes
